Terms and Conditions

Number One Capital Markets, N1CM, hereinafter referred to as the Company invites traders to participate in its " **35% First Deposit Bonus & 25% Re-Deposit Bonus**" ("hereinafter referred to as "the Promotion") subject to the terms and conditions contained herein.

The Promotion is available to all clients provided that they are eligible to participate in the Promotion subject to the Company's eligibility criteria as indicated in the Client Services Agreement and these terms.

For participating in the Promotion, the participants should have already completed the steps required for opening an account with the Company, the client's due diligence and know your client procedures are completed and the account is activated.

The Promotion's conditions:

- 1. Only applicable to verified clients of N1CM trading on the MT4//MT5 trading platform.
- 2. The Promotion offers each verified new client the opportunity to earn up to \$5,000 as bonus. The bonus will be awarded as a 35 % bonus with first deposit after account opening. The maximum bonus amount can reach \$5,000 on a client level and is not calculated per trading account. Any abuse to have multiple profiles to have this promotion is considered as a Trading Abusive Behaviour.
- 3. Clients can have up to three MT4/MT5 Bonus Accounts.
- 4. By participating to the Promotion, the Client acknowledges that s/he has read and agreed

to be bound by these Terms and Conditions as well as to the Client Services Agreement

- 5. To participate in the competition new clients will need to complete N1CM's registration form, complete their Economic profile and upload the required documents in the Client Portal to verify their profile. Once their profile has been approved, Clients can navigate to their Client Portal Choose Open Real Trading Account and select the MT4/MT5 Account type of their preference. The 35 % bonus will be credited to their account after their first deposit.
- 6. Existing clients will be benefiting from the other 25% Re-Deposit Bonus Campaign and when they transfer the required funds from an existing account. Existing clients who has not used Bonus before can talk to N1CM support team to qualify themselves for the promotion.
- 7. In the event that the account balance is 0 (zero) or less, any existing bonus will be removed from the account and any open positions will be closed thereafter at approximately 14:00 GMT. The removal of the bonus funds under the aforementioned conditions may take place prior to or after the specified time
- The Company will not be liable for any stop outs or any other consequences that result out of a Bonus cancellation and/or removal.
- 9. The stop-out level for the client's account will be the point where the equity at any point in time (all client deposits + %35 First Deposit Bonus + (if applicable, %25 Re-Deposit Bonuses) + all realized and unrealized trading profits & losses all withdrawals) is equal to the applicable stop out percentage (usually a rate between %20-%30) of the total margin requirement of the current open trading positions.
- 10. The min. dep. to quality for the bonus promotion is 100USD and the Maximum bonus (sum of first-deposit and re-deposit bonuses) that can be awarded to each individual client is capped at 5000 USD.
- 11. Internal funds transferred between trading Accounts within the Company are considered as withdrawals, therefore the bonus will be removed if the amount being transferred out from the 35% Bonus account is from the original balance that was awarded a respective bonus. For internal transfers between Bonus Accounts, note that the bonus will be transferred proportionally based on the amount being transferred.

12. If the Company suspects that a participant has abused the rules of the Promotion and/or

has been identified to have engaged in abusive trading behaviour in any way, then the Company reserves the right at any time and at its sole discretion to immediately exclude the participant from the Promotion and take additional actions depending on the abuse.

13. The Company will be entitled to (list not exhaustive):

a. deny, withhold, or withdraw from that participant the bonus and any profits generated from the abusive trading behaviour*.

- 14. The Company reserves the right to modify or cancel the Promotion at any time and at its sole discretion or cease this Promotion without any prior notice.
- 15. Both the 35% First Time Deposit and 25% Re-Deposit Bonus promotions only apply to Standard (STD) and ECN accounts. Cent (CNT) accounts are not eligible for the aforementioned bonus programs.
- 16. Please note that if one of our bonus promotions is opted in, with an equity of \$10,000 or less in your live account, the maximum leverage allowed on the related account will be 1:500.



17. The Promotion is open to individuals who are at least 18 years of age and have a solid understanding of FX and CFD trading.

*For the purpose of clause 14.a above, abusive behaviour is considered (list not exhaustive):

- multiple registrations from the same IP address
- trading activities that can be counted as fraud, manipulation or attempts to garner risk free profits
- failure by the client to meet certain requests by the Company related to the Promotion within the specified deadline provided in the correspondence with the Company
- the participation to the Promotion of third parties on behalf of the IB without the proper authorisation or right to act
- trades entered or exited with latencies
